Applying for a new passport is a **three step** process:

Step 1:

Gather the following:

- One completed new passport application. This must be completed on-line at the Department of State's passport portal at <https://pptform.state.gov>. After printing the application do **not sign the application just yet.**

Please make a copy of your DS-11 to include with your Texas Tower order form!

- Two passport type photos. We recommend that you have these pictures taken by a facility familiar with passport photo requirements such as Walgreens, CVS, Kinko's, etc.
- Proof of U.S. citizenship which may be one of the following:
 - **Original** U.S. issued birth certificate
 - **Original** U.S. Naturalization Document
 - An expired U.S. passport that was issued for 10 years
- Two letters (attached below) authorizing Texas Tower to act on your behalf at the Passport Agency. **Please place one inside the sealed envelope and leave one out for us separately.**

Step 2:

Take above documents to:

- An authorized Passport Agency Deputy (**aka a local United States Post Office**). You can find a complete list of agencies at <http://iafdb.travel.state.gov>. You'll likely need to make an appointment in advance.

Please note that the Passport Agency Deputy is required to charge an execution fee of \$25.00 and should be paid separately from the Passport Agency fees.

- The Passport Agency Deputy will collect all of the above documents in step 1, **witness you signing your passport application** and place into an envelope that will be sealed by the Deputy. **Do not open this envelope once sealed as it will void your application.**

Inform the clerk you will forward the sealed envelope to a service in Houston for processing.

Step 3:

Mail your sealed application to us and also include:

- One Texas Tower order form (found on the next page).
Do not put this into the sealed package.
