PHILIPPINE VISA REQUIREMENTS FOR TEMPORARY VISITORS FOR BUSINESS AND/OR TOURISM

- 1. Accomplish F.A. Form No. 2-A (All applications submitted by mail or courier service and through travel agencies or representatives must be duly notarized).
- 2. Submit passport, which should be valid for at least six (6) months beyond the period of stay.
- 3. Attach one (1) 2" x 2" size photo taken within the past six (6) months
- 4. Submit proof of financial capacity to travel:

Tourist:

- A. Round-trip airline/cruise ticket or Certification from the travel agency that the applicant will be in possession of round-trip airline/cruise tickets, and
- B. Copy of checking or savings account

Business:

- A. Round-trip airline/cruise ticket or Certification from the travel agency that the applicant will be in possession of round-trip airline/cruise tickets, and
- B. Letter from company/office requesting the issuance of a visa, guaranteeing financial support to the applicant and stating the nature and duration of the visit
- 5. For a minor traveling alone, or with the person other than his/her parent: Affidavit of consent and support signed by at least on parent
- 6. If applying by mail, please enclose a self-addressed, stamped envelope to ensure the return of the passport (preferably those with tracking numbers)
- 7. Nationals of countries that have diplomatic relations with the Philippines are generally allowed entry into the country without visas for a maximum stay of 21 days or less, provided the nature of the trip is for tourism/vacation. There are, however, exceptions. The maximum length of stay is 59 days, which is extendible with immigration authorities in the Philippines. Please check with the Embassy for further information.
